



IRBM's "Bill Number"

Mandatory reference for payment of taxes effective from 01.01.2023

In a recent media release, the Inland Revenue Board of Malaysia ("IRBM") has informed that a **Bill Number** will be used effective from 1 January 2023 as mandatory reference for all types of direct tax payments except for payments involving –

- Monthly Tax Deductions ("*Potongan Cukai Bulanan*"); and
- Stamp duty.

However, taxpayers can continue to use existing tax reference numbers until **30 June 2023** as reference for tax payment purposes.

How to obtain the bill number

Bill numbers can be obtained from 1 January 2023 from –

- MyTax portal at <https://mytax.hasil.gov.my>.
 - The notices of assessment or estimates and letters of demand issued by IRBM to taxpayers.

Tax payment methods

Tax payments can be made –

- Online; or
- Through the counters at “*Pusat Bayaran Hasil*” or banks appointed as collection agents (“*bank-bank ejen*”)*.

(*) Note:

For payments at the counters, taxpayers are required to print the payment slip or download the bill number by scanning the QR code on the payment slip.

Transition period

During the **transition period** until 30 June 2023, tax identification numbers (TIN) or tax reference numbers can still be used for all types of direct tax payment purposes.
